RE: Medicaid Policy Updates/Changes

PURPOSE: For ABD, Appendix A1 was updated with the 2009 income limits. Examples of nonburial space items were added in Section 2311, and several SUCCESS procedures were updated in Appendix I. For Family Medicaid, sections 2065, 2706 and Appendix M were changed to reflect that checking Databroker is no longer required for RSM PGW or RSM Child cases. A note was added to Section 2405 that The Work Number is acceptable for verifying terminated income, and section 2718 was updated with the new PCK Rebound procedures. Procedures for coding citizenship/identity and 30 1/3 in RSM cases were added to Appendix J. Other minor changes were made in sections 2301 and Appendix D. For Children in Placement, Enhanced Subsidized and Subsidized Guardianship were added to section 2499. Section 2810 was updated with procedures on documenting AFDC criteria for abandoned children, and 2845 now states that the RevMax RMS will complete the SSI or IV-E determination. Section 2853 was updated with new procedures for exempting foster children from GBHC, and section 2870 updated procedures for verifying TPR for foster children and removed procedures for redeterminations of children placed in another state due to COBRA reciprocity. The following forms were revised: 138, 297, 297a, 403, 700, and 700SP. A new OCSS Non-cooperation letter was added, along with versions of the 297, 297A and HIPAA forms in several other languages.
