## MEDICAID MANUAL (OFI Policy Manual, Volume II) Transmittal NO.34

Medicaid Policy Updates/Changes

**PURPOSE:** For all COA's information on Iraqi/Afghani special immigrants was added to Section 2215, and the Case Record Organization section was updated with new procedures on where applications should be filed in the record and on requesting previous records from other counties.

For ABD, Appendix A1 was updated with the 2009 Q-track income limits and mileage rate. New sections were added for Personal Care Contracts and Money Follows the Person. Procedures for determining the countable value of Burial Contracts was updated in the Burial Contracts section. The MRWP/CHSS section is now the NOW/COMP section. Minor changes were made in ABD Requirements, Trust Property, and Notification.

For Family Medicaid, Section 2210 was updated to reflect that an A/R must comply with all requirements necessary to receive other benefits to which they may be entitled. Section 2215 was updated to eliminate the citizenship/identity verification requirement for any child who has received Newborn Medicaid since 2/8/06. Appendix A2 was updated with the 2009 income limits and mileage rate. Appendix J was updated with procedures for coding deprivation and completing APID screens. Minor changes were made in Family Medicaid Application processing, Application processing Overview, BCCP, Cooperation with OCSS, Treatment of Income, Penalized Individuals, Family Medicaid AU/BG Composition changes, and Family Medically Needy.

For Children in Placement, the Chafee Independence Program section was updated with procedures for handling ongoing cases. Minor changes were made in the Transition from Foster Care to Adoption Assistance Section and the Case Record Organization section.

In the Forms section, new NOW/COMP forms and the Women's Health Medicaid Review Form were added, and an updated Form 130 and Burial Exclusion form were added. **DISCUSSION:**
