RE: Medicaid Policy Updates/Changes

PURPOSE: For all COA's, Section 2215 was updated to include information and procedures for allowing an applicant/recipient Reasonable Opportunity for providing verification of citizenship/identity, and the time limit for Iraqi and Afghani special immigrants was removed. Appendix C was updated with the correct GBHC member contact number. A note was also added that the Form 94 and Form 700 do no require a separate Declaration of Citizenship as the necessary language has been added to the forms.

For ABD, Section 2751 was added dealing with the Medicare Savings Program applications that come from SSA. Section 2133 was updated to state that a psychological could be within 3 years of the application date instead of one year. Minor changes were made to Sections 2342, 2410,2418,2430 and 2555. Appendix A-1 was updated with the new Q-track resource limits and the cost guidelines for receipt of Medicare Part D.

For Family Medicaid, Section 2718 was updated with the newest procedures for completing PeachCare for Kids Rebound applications.

There are no changes for Children in Placement.

In the Forms section, the stand alone Burial Exclusion form was removed as it is now part of the Form 985. The newest versions of the 94, 239, 297 and 701 were added, and the new MIPPA cover letter was added
