RE: Medicaid Policy Updates/Changes

PURPOSE: For all COA's, Section 2215 was updated to state that identity does not have to be verified for a child that has been Newborn eligible since 2/8/06, and that identity does not have to be verified for someone to receive EMA. The section was also clarified to state that prior months are not part of the Reasonable Opportunity Period, and that they should be processed like the application and intervening months. Sections 2750 and 2752 were updated with information on how to access exparte and presumptive lists using the GAMMIS system. Appendix C was updated with new contact information and instructions for the HP Contact Center and for correcting Buy-In problems as well as other Medicaid update issues.

For ABD, Appendix A1 was updated with the latest Q-track resource limits. In Section 2230, the DCH Legal Services address was changed. Minor changes were also made to Sections 2205 and 2342.

For Family Medicaid, Appendix J was updated with instructions for accessing and printing reports in GAMMIS. Minor changes were also made to Section 2198.

There are no changes for Children in Placement.

In the Forms section, the latest revisions of the 71, 94, 94SP, 297, 297SP, 173, 700, 705, Medicare Buy-In form and AP Information form were added. New forms for removing members from the RSM and Q-track Exparte lists were added.
