MEDICAID MANUAL (OFI Policy Manual, Volume II) Transmittal

- **RE:** Medicaid Policy Updates/Changes

PURPOSE: To provide DFCS field staff an update to the Medicaid Policy Manual as revised to be in accordance with the most current policy clearances received from the Department of Community Health. Major changes include updated income limits for both Family Medicaid and ABD, and revisions to the renewal policy, including administrative renewals. A detailed overview of all revisions to the Medicaid manual is listed below.

For All Classes of Assistance, whether ABD or Family Medicaid:

 Section 2706 was updated with the 90 day reinstatement policy for renewals in all Medicaid classes of assistance. Policy and procedures for Administrative renewals was added, and section was updated to reflect the 12 month renewal period for MAGI classes of assistance.

For Children in Placement only:

 Section 2819 was updated with steps for CMD process to Former Foster Care Medicaid

For ABD Medicaid only:

Appendix A-1 was updated with the 2014 income limits.

For Family Medicaid only:

- Appendix A-2 was updated with the 2014 income limits.
- Sections 2712, 2713, 2714, 2715, and 2716 were update with policy changes regarding using electronic data sources for renewals and interim changes.
