RE: Medicaid Policy Updates/Changes

PURPOSE: To provide DFCS field staff an update to the Medicaid Policy Manual as revised to be in accordance with the most current policy clearances received from the Department of Community Health. Updates include policy format changes, recent changes to MAGI budgeting, clarifications issued by OCH and verbiage changes to reflect Georgia Gateway.
