## **PURPOSE**

This manual transmittal incorporates into the current policy updates in the Food Stamp Program's income limits, allotments, and the excess shelter cap effective October 1, 2005.

### DISCUSSION

This manual transmittal contains the following updates:

<u>Section 3613 – Standard Deductions</u>, has changed to the following amounts:

- AU size 1-4 \$134
- AU size 5 \$157
- AU size 6 or greater \$179

<u>Section 3617 – Shelter and Utility Deductions</u>, has been updated to reflect the increase in the excess shelter maximum cap to \$400.

<u>Appendix B – Initial Hearings</u>, has been updated to increase the time period for allowing an AU's to request a continuation of benefits pending a fair hearing.

### Appendix A – Financial Standards

Effective October 1, 2005, the eligibility income limits, monthly maximum allotment amounts, standard deductions and the excess shelter maximum cap increased. A copy of the Food Stamp allotment tables reflecting the updated monthly allotment amounts has been added to Appendix A. A local copy of the previous allotment table (October 2004 through September 2005) should be retained on file for claims and restoration reference.

The increases in the allotments and limits were updated in SUCCESS for all actions effective October 1, 2005. All active cases were automatically updated in SUCCESS during the mass modification change that occurred on September 10, 2005 to September 11,2005.

<u>Appendix F, Forms Section</u>, Form 339 ENG/SP, was updated to reflect the change in the income limits for simplified reporting requirements.
