## FOOD STAMP PROGRAM MANUAL TRANSMITTAL NO. 31

- TO: County Departments of Family and Children Services State DFCS Staff
- **FROM:** Rachelle Carnesale, Division Director Divison of Family and Children Services
- **RE:** Food Stamp Program Policy Changes and Updates

**PURPOSE:** The purpose of this transmittal is to add the Tri-Agency (USDA, HHS, and ACF) Guidance regarding social security numbers (SSN), citizenship, and immigration status for applicants and non-applicants in the Food Stamp Program (FSP), to add the requirement to screen review applications for expedited services, to add the requirement to establish TCOS eligibility for review applications, to add the procedures for handling DFCS employee cases; and to update the voter registration requirements.

<u>Section 3005, Confidentially</u> has been updated to cover policy and procedures for handling DFCS employee cases.

<u>Section 3010, Voter Registration</u> has been updated with the most current National Voter Registration Act (NVRA) procedures.

<u>Sections 3100, 3320, and 3325</u> have been updated to include the Federal Triagency Guidance, the requirement to provide an Social Security Number (SSN), citizenship, and immigration status for applicants and non-applicants. Individuals who are applying for food stamp benefits must verify their SSN, citizenship, and/or immigration status. Individuals who are not applying for FS benefits may be designated as non-applicants. Non-applicants do not have to verify SSN, citizenship, and immigration status but are ineligible for benefits. This policy has been added to the FSP manual.

<u>Sections 3110, 3210, and 3710</u> have been updated to add the requirement to screen and provide expedited services for review applications and the requirement to establish TCOS eligibility for review applications. Based on federal regulations, review applications must be screened for expedited services if closed for an expired certification period and TCOS eligibility must be established when an AU is reapplying for food stamp benefits.

<u>Sections 3215, 3220, and 3225</u> have been updated to include the most current contact information for FSP group home certifications (i.e battered women and childrens shelters, drug and alcohol treatment centers, and personal care homes.

The contact information for FNS retailer authorizations and EBT point of sales POS have also been updated.

In Appendix F, Forms, the current revisions to Forms 173SP, 173A, 173A SP, 296, 297, 297A, and 524SP have been included in the manual.
