The purpose of this transmittal is to provide updates to the SNAP National Voter Registration Act (NVRA), citizenship and issuance policies.

Additionally, this transmittal provides policy updates to Appendix E Glossary, and Appendix F Forms. Updates were made to Forms 47, 297, 297A, 508 and 846 (16 languages) to reflect the current contact information for ADA requests. Form 298, Form 299, Form 859 (English and Spanish) was updated to reflect the current contact information for ADA requests. The Form 864 was added as a new form to the policy manual.

The policy revisions include:

- <u>Section 3010 Voter Registration</u> Policy revised based on guidance provided by the Office of General Counsel
- <u>Section 3320 Citizenship</u> Updated definition of Afghan Humanitarian Parolees (Non-SI Parolees) and added definition for Ukrainian Humanitarian Parolees as well as the criteria for eligibility for Afghan Humanitarian Parolees and Ukrainian Humanitarian Parolees.
- <u>Section 3810 Issuance</u> Language in this section is updated to reflect households eligible for zero benefits or an amount less than the minimum allotment will be closed.

The form changes include:
