## TANF PROGRAM MANUAL TRANSMITTAL NO. 30

The purpose of Manual Transmittal #30 (MT 30) is to add, edit, and issue revised policy material. The Middle Class TAX Act and work requirements regarding volunteer quit was added to the policy. Updates were made to Electronic Benefit Transfers and Review issuances, along with updates to Appendix B, Fair Hearings and Appendix F forms.

Minor corrections to previously approved policy and typographical errors have also been made where necessary, but are not noted in this transmittal. In addition, minor stylistic changes and rearrangement of sentences and/or paragraphs that do not contain substantive changes or create new policy are also not identified.
